## Today, A Day of Honors


### Dr. Ira D. Gruber to be Speaker



# Minutes of the Meeting of November 18, 2006

The Cradle of Texas Chapter of the Texas Society of the Sons of the American Revolution met at "Windswept" Restaurant in Oyster Creek, Texas at 11:30 AM, Saturday, November 18, 2006. Members present were Arnold Seidule, Garvin Germany, Don Pugh, George Easterling, Tillman Daniel, Milton Wing, Russell Dart, Jim Salisbury, Donald Mudd, Julian W. Taylor III, Roger Byler, and prospective member Thomas Mudd. Guests included Janice Seidule, Coryne Boggs Choate, Mary Nita Wing, Dot Salisbury, Bellamy Hoffman and Elizabeth Melton.

President Tillman Daniel called the meeting to order by asking Reverend Roger Byler to lead us in the Invocation. Compatriot George Easterling lead us in the Pledges to the Flags and the SAR Opening.

President Daniel welcomed members, wives, DAR visitors and Tom Mudd, a prospective member. Daniel asked for unfinished business, of which there was none. He asked the Chapter to vote on the minutes as published in the "Cradle Crier" newsletter. A motion was made, seconded and the minutes were approved as written. President Daniel then called for new business and officers reports, of which there was none. Compatriot Arnold Seidule reminded the Chapter members of State Society President Tom Green's invitation to attend a flag presentation at a local school.

President Daniel reminded the members that they would be receiving their dues letters in the mail. He urged us to pay promptly because of the Houston Board of Managers' recent emphasis on expeditious and full financial participation of every member. The Chapter was reminded of the invitation of Galveston's Bernardo de

Galvez Chapter invitation to come to the commemoration of 110<sup>th</sup> anniversary of the SAR in Texas on Saturday, December 9<sup>th</sup>, 2006. There will be a rededication of the Texas state historical marker at 23rth and Church Street. The rededication will be preceded by a meeting and meal at Gaido's Pelican Club. Compatriot Don Pugh reminded the Chapter that we will be having our own meeting at 11:30 AM on the same day, December 9, 2006, but that it will be possible to attend our meeting and the rededication of the historical marker at 23<sup>rd</sup> and Church Street in Galveston.

President Daniel asked Dr. Pugh to present for discussion the proposed amendments to Article V of Chapter's constitution and Article III of the By-laws.

Dr. Pugh indicated that the amendments would increase the Board of Managers and the number of officers. Upon the suggestion of President Daniel, copies of the proposed amendments were distributed to all members. The amendments were read. The amended Article III By-Laws amendment makes the Chapter Board of Managers "Executive Committemen". The amended Article V of the Constitution makes Executive Committeemen "officers, whose duties "are outlined in the By-Laws." Dr. Pugh said that the required vote of the general membership on the proposed amendments would take place at the December 9 meeting.

President Daniel called on Mike Rees to introduce the program. Mike introduced Dr. Lawrence Jablecki. Mike cited his work as Director of Brazoria County Texas Department of Criminal Justice Community Supervision, his Vanderbilt Masters and Ph.D. from Manchester, U.K., and his teaching at University of Houston at Clear Lake and Rice University as qualifications for addressing the Chapter on "The Natural Rights of Man and the American Revolution".

Dr. Jablecki contrasted the romanticized view of the "founding fathers" with their practical concerns about the abuses of the English. He had Mike Rees read from a 1779 edition of the Annual Register the introductory words of the Declaration of Independence.

He said that the founding fathers were not just wealthy men with economic interests which would be furthered by independence; they were willing to radically transform society. The concept of the natural rights of men had existed from the time of John Locke, an English political philosopher. Locke published two treatises in 1690: one on government and the other on royal paternalism.

Locke insisted that the sovereign is not our father; that the relationship is contractual; that in the state of nature there was no sovereign; that we authorized the sovereign to rule but the relationship is one of trust and duty; that the sovereign must insure "life, liberty, and property". These ideas were also developed in the writings of Montesquieu, John Trencher, Hume, Rousseau. All insisted that man comes into the world entitled to natural rights granted by God. Although these writers, and most

of the founding fathers were not orthodox Christians, they believed in providence at work in history.

Dr. Jablecki outlined the controversy between the federalists and the anti-federalists. Federalists Madison and Hamilton first didn't think it was necessary to express



the natural rights of man in the Constitution. Madison wrote in the Federalist Papers #84 that a bill of rights would weaken the Constitution. Anti-federalists Patrick Henry, George Mason and others urged that the Constitution needed a bill of rights. The anti-federalists the federalists accused wanting to replace one form of slavery with another.

The federalists prevailed with the ratification of the Constitution, but the anti-

James Madison the Constitution, but the antifederalist soon were able to ratify the "Bill of Rights". The first ten amendments to the Constitution were 12 original amendments collapsed into ten. These were thought to be derivative from universal abstract principles applicable to our young Republic.

Dr. Jablecki said that some thought the founding fathers were elitists-that they didn't really believe in equality but liberty. He thought that modern Americans sometime indulge in anachronistic interpretations of what the

founding fathers envisioned, lifting their words out of historical context. Locke invested in the slave trade, and of course, Jefferson and Madison were slave owners.

Dr. Jablecki said that they did not envision general constitutional rights to privacy or envision (need for) gun control. The words of the Constitution and the Bill of Rights, in their

"majestic generality" do not always give us answers. Nor

did the writers of the Constitution think that the Constitution embodied "eternal truth". They thought of it as a structure. But they did believe in natural rights, abstract principles that were true everywhere.

The great issue which was yet to be resolved was slavery. Some think that Jefferson wrote "life, liberty, and the pursuit of happiness" instead of "life, liberty, and property" because he had compunctions as a man of the "enlightenment" about slavery.

Dr. Jablecki suggested that the Civil War was the last great battle of the Revolutionary War. It is ironic, he said, that both Jefferson and Madison died on July 4, 1826,

exactly 50 years after the Declaration of Independence. Jefferson worried to the end about the politically destructive tendency of slavery. In that year, a speaker in Windsor, Vermont prophesized that if the northern abolitionists did not proceed gradually and temperately with the people (of the south), the Constitution and Bill of Rights would be destroyed with the Union.

Dr. Jablecki concluded that the writers of these documents were intellectual giants. Even though they were practical men of a particular time and place they had a belief in universal natural rights of men which surfaces in the consciousness of our Nation in times of conflict, and greatness.

Reverend Byler compared our nascent Republic to that of Rome, of which he has been reading much lately. Compatriot Seidule asked if slavery would have been phased out without a war.

Dr. Jablecki said that the arguments of Wilberfoce had abolished slavery in England; perhaps it could have happened here. Compatriot Taylor pointed out that we had outlawed the importation of slaves.

President Daniel asked if any democracy had lasted as long as we. Compatriot Tom Mudd pointed out that the Roman Republic had endured longer, but it fell to the Empire.

President Daniel thanked Dr. Jablecki, to whom Mike Rees presented a certificate of appreciation.

Reverend Roger Byler led us in a brief Benediction followed by the members reciting the SAR closing. President Daniel adjourned the meeting.

The 110<sup>th</sup> Anniversary of the Texas Society will be celebrated on the afternoon after our meeting on December 9 at 3 PM in Galveston at the corner of 23<sup>rd</sup> Street and



Church Street at the site of the Old Tremont Hotel (not the current hotel of the same name) where J. Hobart Evans served as the organizer and first president of the Galveston Chapter of the Sons of the American Revolution and the beginning of the Texas Society in 1896. We are urging all

members of the Society to drive over to Galveston and participate in this recognition. We will have color guard members and local Galveston politicians in attendance and President Tom Green will be assisting in the event.

To get to the site, stay on Broadway as you come on the island and turn left on 23<sup>rd</sup> street and go about 4 blocks and the historical marker is on the west side of 23<sup>rd</sup> street.
