Meeting Minutes

Sons of the American Revolution Cradle of Texas Chapter 33 February 12, 2022

The Sons of the American Revolution, Chapter 33, met February 12, 2022 at The Swamp Shack in Lake Jackson, Texas.

Call to Order: President Wiggins called the meeting to order at 11:44 a.m.

Invocation: The invocation was given by Bill Sanders.

Pledges: Vice President Rodney Weems led the pledges to the flags of the United States, Texas, and the Sons of the American Revolution.

Introduction of Guests: Our program speaker, Epphilia Kennedy, and her daughter Serena were introduced by President Wiggins. Bill Sanders introduced Bill Yates, a prospective member.

Award Presentation: The Silver Good Citizenship Medal was presented to Epphilia Princess Kennedy for her humanitarian work by Vice President and Programs Committee Chairman Rodney Weems.

Program: After being introduced by President Wiggins, Epphilia Kennedy of Angleton spoke about operation Serena and her humanitarian efforts. Ms. Kennedy's daughter Serena, visiting family in Lebanon, became trapped there in 2006 during the war between Israel and Hezbollah. Mrs. Kennedy, a

naturalized U.S. citizen of Turkish origin, became involved in efforts to extract her two-year-old daughter. Eventually, with the help of the U.S. government, Serena was able to leave Lebanon through Syria. Turkish media ran the story. Because of the publicity associated with "Operation Serena", Ms. Kennedy became involved in efforts to help others in similar circumstances. In 2019, two Turkish citizens were working in a restaurant in Libya, in an area controlled by Libyan warlord Kalifa Haftar. They were arrested and detained apparently for inadvertently taking pictures of a military convoy. Their families contacted Ms. Kennedy asking for her help. Lengthy efforts ensued, involving the U.N., NATO, the Turkish and U.S. governments. Eventually, she used social media to get world attention. Ads were run on Facebook against Haftar including the detainees' pictures and maps of all Libyan prisons. People from the areas responded. Responses included multiple threats against her and the detainees. Responses also included information concerning the prisons. This apparently prompted the U.N. to pressure the Turkish government to intervene with the Libyan government. Information was received the detainees were alive, and they were eventually released. President Wiggins presented Ms. Kennedy with a Certificate of Appreciation.

Minutes: The minutes from the January meeting were approved on a motion by Win Avera second by Bill Griffiths.


